PRESS NOTE

Based on the information gathered from District Election Officers and Superintendent of Police, the following information on Model Code of Conduct violation and Law & Order enforcement is provided:

Model Code of Conduct:

As on date there are 1156 Flying Squads and 1255 Static Surveillance Teams have been activated. Flying Squads and other Model Code of Conduct Teams constituted for the purpose of enforcement on Model Code of Conduct have cumulatively removed **12537** number of Wall Writing, **17693** numbers of posters and **7711** number of banners from public property and have lodged **06** Cases under Karnataka Open Places (Provisions of disfigurement) act 1981. From Private Property cumulatively **6866** number of Wall Writing, **7949** number of posters and **2543** number of banners were removed.

Further, Static Surveillance Teams have seized Cash worth Rs. 4,58,16,060/- and 02 vehicles in last 24 hours. Cumulatively, the Static Surveillance Teams have seized **Rs. 8,75,11,130/-** cash, Gold 7 Kg 303 Grams worth **Rs. 1,70,80,000/-**, Silver worth **Rs.11,47,200/-**, 54 Sarees, 4.5 litres of Liquor and vehicles & other items worth **Rs. 1,32,32,772/-**.

Further, Flying Squads Teams have seized Rs. 56,01,100/- Cash, 33 litres of Liquor worth Rs. 10,190/-, 10 vehicles worth Rs. 8,00,000/-, 965 Cheques valued Rs. 2,98,48,000/-, 190 LPG Stove worth Rs. 3,48,000/-, 900 Note Books worth Rs. 65,000/-, 52 Sarees & Blouse worth Rs. 4,680/-, 12 Bags BJP Symbol Sarees worth Rs. 1,800/- and "T" shirts worth Rs.400/- in last 24 hours. Cumulatively, the Flying Squads Teams have seized **Rs.1,15,33,350/-** Cash, **556.785** litres of liquor, other items worth **Rs.13,00,72,980/-**, **37** vehicles worth **Rs. 1,00,96,560/**. Other Police authorities they have seized cash worth Rs. 7,00,000/- & 10 Sarees, 160 Laptops and 485 Litres of Liquor.

Cumulatively, Flying Squads, SSTs and other police authorities have seized Cash worth **Rs. 9,97,44,480/-**.

Flying Squad Teams & other Police authorities have booked FIRs in 29 Cases of Cash/other items related to seizure and other MCC related violations in the last 24 hours. Cumulatively, Flying Squads they have registered FIRs in 245 Cases. SSTs they have registered FIRs in 03 cases of Cash/other items related to seizure in last 24 hours. Cumulatively, Static Surveillance Teams have registered FIRs in 56 Cases.

While Excise department have seized 3,472.01 litres of IML & other liquor worth Rs. 9,26,798/- and booked 77 Heinous cases, 124 cases for Breach of Licence conditions and 144 cases under Section 15 (a) of Karnataka Excise act 1965 in last 24 hours. Cumulatively, **15,505.027** litres of IML & other liquor worth **Rs. 61,80,645/-** and booked **552** Heinous cases, **859** cases for Breach of Licence Conditions, **02** NDPS case and **1339** cases under Section 15 (a) of Karnataka Excise act 1965. And also 234 different types of Vehicles have been seized.

LAW & ORDER:

948 arms have been got deposited, 1041 persons were bounded over under preventive sections of CRPC, and 1868 Non-bailable warrants were executed, preventive sections of CRPC booked in 645 cases, 854 Nakas made operational in the last 24 hours. Cumulatively, 64126 arms have been got deposited since the date of enforcement of Model Code of Conduct and arms 95,403 arms have been deposited till date, 50 arms were impounded, 4 armed license have been cancelled, preventive sections of CRPC are booked in **11182** cases, **9881** persons were bounded over under preventive sections of CRPC and **19785** Non-bailable warrants were executed from the date of enforcement of elections.
