2. Model Code of Conduct-

The by-election for the 15 assembly constituencies of Karnataka has been announced, with the election process beginning on 11-11-2019, with the Code of Conduct coming into force. The Model Code of Conduct shall be as follows, as clarified in Directive No: 100 / KT-LA / 2019, dated 01-10-2019(available on the commission's website), Election Commission of India.

The Model Code of Conduct applies to the full range of districts across the district.

The Model code of conduct shall be applicable to all candidates, political parties and the state Government concerned. The Model code of conduct shall also be applicable to the Union Government for the district of the State concerned.

3. Identification of Voters-

In consonance with the past practice, the Commission has decided that the voter's identification shall be mandatory in the aforementioned election at the time of poll' Electoral Photo Identity cards (EPIC) shall be the main document of identification of a voter. However, in order to ensure that no voter is deprived of his/her franchise, if his/her name figures in the electoral rolls, separate instructions will be issued to allow additional documents for identification of voters at the time of poll in the said election.

9. Training:

The General Elections were held very recently and all the officers involved at various levels have already been trained in election management. However, one more level of training will be organized for them. Cascaded training will also be organized for officers at all levels in due course

10. Standard Rate Card of News papers / TV / Radio / Channels etc:

During the recently held Lok Sabha Elections, rate cards have been prepared and put to use. The General elections were held during April 2019 and the same rates will be adopted for the bye elections also for the purpose of MCC and Expenditure Monitoring.

11. State Level Single Window Committee

The State Level Single Window Committee provides permission for the following:

- Permission for transportation of publicity materials (1 vehicle for every 25 Assembly Constituencies)
- Vehicle permission for State level office bearers (5 per Political Parties)
- Permission for Video Vans (There is no limit for number of vehicles.
- Star Campaigner permission (40 per recognised political parties and 20 for Registered Political Parties)

12. Complaint management:

1. An integrated Complaint Monitoring and Media Monitoring centre has been established in the O/o Chief Electoral Officer, 2nd floor, East Wing, Khanija Bhavan, Race Course Road, Bengaluru.
2. Political parties, contesting candidates and General Public can register complaints in the cell through the following modes:
 - i. Letters
 - ii. Emails by writing to ceo.karnataka@gmail.com
 - iii. By logging into National Grievances Redressal System (NGRS) web portal.
 - iv. For reporting violations of Model Code of Conduct cVIGIL mobile applications is available for both Android and iPhone users.
 - v. By calling 1950 toll free number for District Voter Helpline and 1800 4255 1950 for State Voter Helpline.
3. Dedicated teams have been formed to continuously monitor various media like Print, Electronic etc. A separate Social Media Monitoring Cell is formed to take note violations on Social Media.
4. Similar arrangements have been made at district and Assembly Constituency levels.

13. Help Desk:

As of now help desk is available in the ERO offices to handle the roll related issues. Instructions have been issued to set up help desk even in RO Offices.

14. REQUEST TO POLITICAL PARTIES :

- Give wide publicity to the schedule to the people.
- Political parties are requested to appoint BLAs and to actively participate in the roll updation process.
- Electors from these constituencies are called upon to check their names and to ensure that their names are at only one place.
