**NOTIFICATION**

No. 100/KT-LA/17/2019:- Whereas, the seat of Sh. Adaguru H. Vishwanath in the Legislative Assembly of the State of Karnataka elected from 212-Hunsur Assembly Constituency has become vacant on 28<sup>th</sup> July, 2019, by reason of his becoming subject to disqualification under clause (2) of Article 191 of the Constitution read with the Tenth Schedule thereto; and

2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;
3. NOW, THEREFORE, in pursuance of sub-section (1) of section 150 and sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-
  - (A) calls upon the said 212-Hunsur Assembly Constituency in the State of Karnataka, to elect, before 27<sup>th</sup> October, 2019 (Sunday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State;
  - (B) appoints, with respect to the said election,-
    - (a) the 30<sup>th</sup> September, 2019 (Monday), as the last date for making nominations;
    - (b) the 1<sup>st</sup> October, 2019 (Tuesday), as the date for the scrutiny of nominations;
    - (c) the 3<sup>rd</sup> October, 2019 (Thursday), as the last date for the withdrawal of candidatures;
    - (d) the 21<sup>st</sup> October, 2019 (Monday), as the date on which a poll shall, if necessary, be taken ; and
    - (e) the 27<sup>th</sup> October, 2019 (Sunday), as the date before which the election shall be completed; and
  - (C) fixes the hours from 7.00 A.M. to 6.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
