No. 318/CS-Multi/2/2020(1): - Whereas, the President of India has, by notification issued under Section 12 of the Representation of the People Act, 1951(43 of 1951) and published in the Gazette of India on **02nd June, 2020** been pleased to call upon the elected members of each of the Legislative Assemblies of the States, specified in column (1) of the TABLE below, to elect to the Council of States, the number of member(s) specified against that State in column (2) of the said TABLE:

- (b) the 10th June, 2020 (Wednesday), as the date for the scrutiny of the nominations;
- (c) the 12th June, 2020 (Friday), as the last date for the withdrawal of candidatures;
- (d) the 19th June, 2020 (Friday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 22nd June, 2020 (Monday), as the date before which the election shall be completed; and

(B) fixes the hours from 09:00 am to 04:00 pm, as the hours during which the poll shall, if necessary, be taken in all the above mentioned States on the date specified above for the election.
