## Brief Note of the Issue:

## 1. Sri. P C Mohan (Bharatiya Janata Party)

During the account reconciliation meeting held on 19.06.2019, it was noticed that, the candidate's expenditures as per the Shadow Observation register is Rs.73,27,726 and as per the candidate's declaration it is Rs.41,33,821. The committee finds the difference between the shadow observation register and candidate's expenditure registers as Rs.32,43,785.

Thereafter, it was decided to issue a notice in this regard seeking clarification from the candidate for the difference in the expenditure between shadow observation register and candidate expenditure register. In reply to the notice issued, the candidate submitted in his letter dated: 20.06.2019 that only Rs.22,62,595.00 was spent on 13-04-2019 for the public meeting at Palace Grounds attended by Hon'ble Prime Minister Sri

- 1. In his detailed reply statement, he has been pointed out that the expenses booked towards vehicle, Band set rents and Loudspeakers and Vediography are duplicated and requested for considering it ones.
- 2. The expenditure booked with regard to voter slips printing machine rent has been disputed and requested for re-account @ Rs. 200/- for total of 91 machines and voter slips printing cost to accounted @ Rs.1.00 for 2085 pages.
- 3. The Candidate disputing the total Polling day expenses booked as per shadow register Rs. 14,37,091. Requested for not to considering expenditure booked towards outside workers and minimise the expenses booked towards Shamiyana, chairs and tables.

The DEMC has examined the written reply statement submitted by the candidate and found that some of the explanation and justifications given by the candidate have been considered the following item of expenditure booked.

The Polling Day and Counting Day expenditure booked has been reconsidered based on the representation made by the candidate. Similarly Meeting hall rents, vehicle rent, Bandset charges, printing of voter slips cost and printing machine rents, loudspeakers rent and others also have been revised and duplicated costs have been agreed to exclude from the total estimated expenditure.

After carrying out the above revisions based on the clarifications provided by the candidate, the DEMC has finally concluded that, the final expenditure of the candidate as Rs 6628181. This is within the prescribed expenditure limit of Rs. 70 Lakhs. The Details of the same could be found in the Scrutiny report of the DEO for Bangalore Central PC.

1. With this the committee has resolved to accept and consider the final expenditure of Sri. P C Mohan (Bharatiya Janata Party) as per the shadow observation register is **Rs 67,44,075** and for that of Sri Rizwan Arshad (Indian National Congress) candidate final expenditure is **Rs 66,28,181.** 

Narendra Damodardas Modi. Hence he has requested for re-accounting as per the guidelines and actuals. The candidate further submitted one more reply on 21,06.2109 specifically mentioning some of the items for which expenditure either have been duplicated or booked in excess. With the said requests he has appealed to the DEMC for reconsideration of the accounting of some of the expenditure and concluded that he has not exceeded the prescribed expenditure limit of Rs. 70 Lakhs.

## **REVIEW OF THE COMMITTEE:**

The DEMC agreed to go by the apportioned portion of the PM's Election Rally as computed by the North Loksabha Constituency as prescribed in Election Expenditure Compendium.

The Polling Day and Counting Day expenditure booked has been reconsidered based on the representation made by the candidate, Similarly Meeting hall rents and other expenditure such as shamiyana & Chairs have also been downward revised.

After carrying out the above revisions based on the clarifications provided by the candidate, the DEMC has finally arrived at the final expenditure of the candidate as Rs 67,44,075. This is within the prescribed expenditure limit of Rs. 70 Lakhs. The Details of the same could be found in the Scrutiny report of the DFO for Bangalore Central PC.

## Sri Rizwan Arshad (Indian National Congress)

During the account reconciliation meeting held on 19.06.2019, it was noticed that, the candidate's expenditures as per the Shadow Observation register is Rs.73,77,606 and as per the candidate's declaration it is Rs.65,60,402.00. The committee finds the difference between the shadow observation register and candidate's filed expenditure.

Thereafter, it was decided to issue a notice in this regard seeking clarification from the candidate for the difference between shadow observation register and candidate expenditure register. However, in reply to the notice issued, the candidate replied in his letter dated: 21.06.2019 disputing the following expenditure booked in the shadow register:

- 2. The expenditure booked with regard to voter slips printing machine rent has been disputed and requested for re-account @ Rs. 200/- for total of 91 machines and voter slips printing cost to accounted @ Rs.1.00 for 2085 pages.
- 3. The Candidate disputing the total Polling day expenses booked as per shadow register Rs. 14,37,091. Requested for not to considering expenditure booked towards outside workers and minimise the expenses booked towards Shamiyana, chairs and tables.
