f. Photo Electoral Rolls

Photo Electoral Rolls will be used during this Bye Elections to Chincholi and Kundgol Assembly Constituencies and photo percentage in Photo Electoral Rolls of Chincholi and Kundgol Assembly Constituencies are 100 % in each of the Constituency.

g. Electors Photo Identity Cards (EPIC)

Identification of the voters at the polling booth at the time of poll shall be mandatory. Electors who have been provided with EPIC shall be identified through EPIC. Presently, the EPIC coverage in Chincholi and Kundgol Assembly Constituencies are 100 % in each of the Constituency.

h. Photo Voter Slips (PVS) – No Longer a standalone identification document for Voting:

To facilitate the voters to know where he/she is enrolled as a voter at a particular polling station and what is his/her serial number in the Electoral roll, the voter slip bearing the Photo of the elector (wherever present in the roll) has already been distributed. The Commission has in its instruction dated 28th February 2019, on alternate document has specified that the Photo Voter Slips shall not be accepted as a stand-alone identification document for voting, the words 'THIS SLIP WILL NOT BE ACCEPTED FOR THE PURPOSE OF IDENTIFICATION IN POLLING STATION. YOU ARE REQUIRED TO CARRY EPIC OR ONE OF THE 11 ALTERNATIVE DOCUMENTS SPECIFIED BY THE COMMISSION FOR VOTING" has been printed on the Photo Voter slip.

i. Alternative Documents:

The Commission has vide its direction dated 28th February 2019, notified 11 alternate photo ID card to establish their identity. In order to ensure that no voter is deprived of his/her franchise, if his/her name figures in the Electoral Rolls, and the voter is not able to produce his Voter ID card, then he may produce any of the following photo ID cards to establish his identity –

- 1. Passport.
- 2. Driving License.
- 3. Service identity Card with photography issued to employees by Central/State Government/PSUs/Public Limited Companies.
- 4. Passbooks with Photographs issued by Bank/Post Office.
- 5. PAN Card.
- 6. Smart Card issued by RGI under NPR.
- 7. MNREGA Job Card.

- 8. Health Insurance Smart Card issued under the scheme of Ministry of Labour.
- 9. Pension document with photograph.
- 10. Official Identity Cards issued to MPs / MLAs / MLCs and
- 11. Aadhaar Card.

j. Measures to prevent impersonation of Absentee Voters:

BLOs have visited door to door and identified a list of voters found absent from their place of residence. Similarly the names of dead, shifted shall also be added to the list. ASD list has already been prepared and there are 4,285 and 4,083 identified Chincholi and Kundgol Assembly Constituencies respectively.

4. Polling stations.

8. EVM-VVPAT Training and Awareness:

In order to create awareness among the electors about the use of VVPAT, special teams are arranged equipped with VVPATs and EVMs. These teams have visited various parts of the Bye Elections to Chincholi and Kundgol Assembly Constituencies with these machines and explained to the people about the use of VVPATs and also it's functioning. The voters are allowed to use the machines and see how it works by casting their votes. The details of voter's participation and vote casted in awareness campaign are given below. A total of **3,83,305 voters** have participated and **2,35,785 voters have casted their votes** during the awareness programme in Bye Elections to Chincholi and Kundgol Assembly Constituencies, going for poll on 19.05.2019.

14. Issuance of Orders Under 144 Cr.Pc:

The District Magistrates of Assembly Constituencies have issued orders under Section 144 of the Criminal Procedure Code, 1973, as per ECI guidelines and it is specifically clarified in the order passed that, this order does not restrict house-to-house visits during 48 hours in connection with door-to-door campaigning.

15. Restriction on presence of political functionaries in a constituency after the campaign period is over:

The Presence of the Political functionaries and persons who are not voters of the constituencies is restricted after the campaign period is over i.e., from 6.00 pm of 17.05.2019.

16. Excise Enforcement:

Dry days have been declared in the ACs where Elections are being held on 19.05.2019 i.e., from 6.00 pm of 17.05.2019 to 6.00 am of 20.05.2019.

17. Use of Loudspeaker:

There is a restriction on use of loudspeakers during 48 hours i.e,. from 6.00 pm of 17.05.2019 onwards.

18. Media Matters:

a. Restrictions on exit poll & opinion poll:

All the Political Parties, Media Houses have been apprised of the restriction on Exit of Poll & Opinion Polls as per ECI directions i.e., from 7.00 am of 11th April 2019 (Thursday) to 6.30 pm of 19.05.2019 (Sunday).

b. Election Media Monitoring Centre (EMMC):

Separate cell has been created to ensure timely sending of ATRs on EMMC Reports.

The rate for the vehicles in consultation with the Transport Commissioner is fixed and GO is issued. Around 301 vehicles of different types will be needed for transportation of PWDs for Bye-elections to Chincholi and Kundagol Assembly Constituencies.

24. Welfare measures, including health, for polling personnel and voters.

The DEOs have been instructed to have separate review on the subject, identifying the concern and asked to take advance measures to address facilitation.

Nodal officers for welfare in the district will coordinate and supervise the polling personnel welfare measures.

- (a) The information about the training program, despatch and reception in proper and timely manner.
- (b) Facilities and proper arrangement at training venue like help desk, drinking water, and toilet.
- (c) Proper facilities at the despatch centre like drinking water, toilet
- (d) Timely despatch and proper transport arrangement
- (e) Coordination between police personnel to be deputed for election duty.
- (f) Proper health care response teams to attend in medical emergency conditions.
- (g) Food arrangement
- (h) The timely relieving of the poll personnel form the election duty
- (i) The arrangement for the polling personnel to be transported back to home after the reception at the earliest
- (j) Cashless transfer of honorarium to the polling personnel in advance Exclusive chapter on welfare measures in the DEMP
- (k) Ex-Gratia compensation in case of death of Polling Personnel while on duty to be sanctioned at the earliest.
- (l) Meeting with the Secretary, Health Department and Commissioner, Health Department was conducted and were requested to issue necessary instructions to the Field Officers to look after the welfare of the Polling Personnel's.

b. Report MCC Violations:

The CEO Karnataka also urges the citizen to download the **cVIGIL Mobile App** from the Google Play Store or the App Store and report the MCC Violations happening on the last day before poll and campaigning during the ban period and other unethical campaigning by the candidates and political parties for the field units to take immediate action.

26. Complaints monitoring

a. 1950 Voter helpline

State and Districts Voter Helplines are setup for receiving grievances and complaints from the citizens regarding various electoral matters and redressal of the same. The details of calls made by the citizens for obtaining information, providing feedback and suggestion and filing complaints and their disposal is given below. A total of 1349 calls (Information- 1326, Feedback- 11, Suggestion-0 and complaints- 12) have been received in Bye Elections to Chincholi and Kundgol Assembly Constituencies, out of which 1349 have been disposed of.
