No. 100/KL-LA/1/2017:- **Whereas**, the seat of Shri. V. Srinivasa Prasad, in the Legislative Assembly of the Karnataka State, elected from 214- Nanjangud (SC) Assembly Constituency has become vacant on 20-10-2017, by reason of his resignation; and

2. Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. Now, therefore, in pursuance of sub-section (1) of Section 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby: -

(A) Calls upon the 214-Nanjangud (SC) Assembly Constituency in the State of Karnataka to elect, before the 15th April 2017 (Saturday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, belonging to any of the Scheduled Caste of the State for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

(B) Appoints, with respect to the said election:-

- the 21.03.2017, (Tuesday) as the last date for making nominations;
- the 22.03.2017, (Wednesday) as the date for the scrutiny of nominations;
- the 24.03.2017, (Friday) as the last date for withdrawal of candidatures;
- the 09.04.2017 (Sunday) as the date, on which a poll shall, if necessary, be taken;
- the 15.04.2017 (Saturday) as the date before which the election shall be completed, and

(C) Fixes the hours from **7.00 A.M.** to **5.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
