## NOTIFICATION

No. 100/KT-LC/2/2016: - WHEREAS, the seat of Shri Y.A. Narayana Swamy in the Legislative Council of the State of Karnataka, elected from Karnataka South-East Teachers' Constituency, has become vacant on 17<sup>th</sup> February, 2016, by the reason of his election as MLA to Karnataka Legislative Assembly, before the expiration of his term of office which was upto and including the 21<sup>st</sup> June, 2018; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW, THEREFORE, in pursuance of sections 151, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby -

- (A) calls upon the said Karnataka South-East Teachers' Constituency, in the State of Karnataka, to elect, before 9<sup>th</sup> February, 2017 (Thursday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Council of the State; and
- (B) appoints, with respect to the said election, -
- The 17<sup>th</sup> January, 2017 (Tuesday), as the last date for making nominations;
  - The 18<sup>th</sup> January, 2017 (Wednesday), as the date for the scrutiny of nominations;
  - The 20<sup>th</sup> January, 2017 (Friday), as the last date for the withdrawal of candidatures;
  - The 3<sup>rd</sup> February, 2017 (Friday), as the date on which a poll shall, if necessary, be taken; and
  - The 9<sup>th</sup> February, 2017 (Thursday), as the date before which the election shall be completed; and
- (C) fixes the hours from 8.00 A.M to 4.00 P.M., as the hours which the poll shall, if necessary, be taken on the date specified above for the election.
