The revised schedule is as under:

7.	Period for filing claims and objections.	23.11.2016 (Wednesday) to 19.12.2016 (Monday)
8.	Date by which the claims and objections shall be disposed of and supplements be prepared and printed.	06.01.2017 (Friday)
9.	Final Publication of Electoral Rolls.	12.01.2017 (Thursday)

I am further to enclose herewith the Commission's notification dated 07th December, 2016 issued under Rule 12 of Registration of Electors Rules, 1960, with the request that the same should be got published in the extraordinary issue of State Gazette. 3 offtake copies of the same may please be sent to the Commission for its information and record.

NOTIFICATION

Whereas, the Election Commission had announced the schedule for de-novo preparation of electoral rolls in respect of certain Graduates' and Teachers' Constituencies of State Legislative Councils of Andhra Pradesh, Bihar, Karnataka, Maharashtra, Telangana and Uttar Pradesh with reference to 01.11.2016 as the qualifying date vide its letter No. 37/LC/LET/ECI/FUNC/ERD/ER/2016, dated 16th September, 2016; and

Whereas, the period of filing claims and objections was fixed from 23rd November, 2016 to 8th December, 2016; and

Whereas, the draft rolls were published on 23rd November, 2016; and

Whereas, Chief Electoral Officers of Andhra Pradesh & Telangana and Uttar Pradesh have requested for extension of the period of filing claims and objections due to certain administrative reasons; and

Whereas, the Election Commission has considered the matter and decided that the period of filing claims and objections in certain Graduates' and Teachers' Constituencies of Legislative Councils of Andhra Pradesh, Bihar, Karnataka, Maharashtra, Telangana and Uttar Pradesh should be extended up to 19th December, 2016 (Monday);

Now, therefore, the Election Commission, in exercise of the powers conferred by proviso to Rule 12 of the Registration of Electors Rules, 1960, extends, for the said Graduates' and Teachers' Constituencies of Legislative Councils of the States mentioned above, the period for filing claims and objections upto 19th December, 2016 (Monday) for ongoing preparation of electoral rolls with reference to 01.11.2016 as the qualifying date.
