### NOTIFICATION

No.100/KT-LC/01/2020-MLA (1): - Whereas, the seat of **Rizwan Arshad** in the Legislative Council of the State of Karnataka, elected by the members of the Legislative Assembly of the State, has become vacant on 09.12.2019 by the reason of his election to Karnataka Legislative Assembly, before the expiration of his term of office which was up to and including 14.06.2022; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW, THEREFORE, in pursuance of section 151, sub-section (1) of section 39 and section 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

(A) **calls upon** the members of the Legislative Assembly of the State of Karnataka to elect, before 18<sup>th</sup> February, 2020 (Tuesday), and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Council of the State;

(B) **appoints** with respect to said election, -

- the 06<sup>th</sup> February, 2020 (Thursday), as the last date for making nominations;
- the 07<sup>th</sup> February, 2020 (Friday), as the date for the scrutiny of the nominations;
- the 10<sup>th</sup> February, 2020 (Monday), as the last date for the withdrawal of candidatures;
- the **17<sup>th</sup> February, 2020 (Monday)**, as the date on which a poll shall, if necessary, be taken; and

- (e) the 18<sup>th</sup> February 2020 (Tuesday), as the date before which the election shall be completed; and  
(C) **fixes the hours from 9.00 a.m. to 4.00 p.m.**, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
