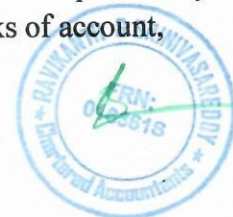

- (iii) The Balance Sheet, Income and Expenditure Account and Receipt & Payment statement dealt with by this report are in agreement with the books of account,



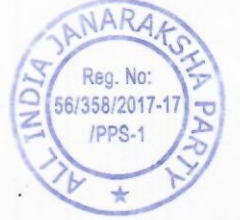

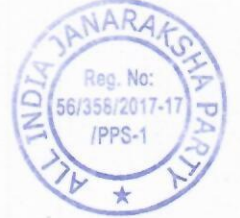
