Date: 05-01-2023

With regard to Special Summary Revision of photo electoral rolls w.r.t 01.01.2023 as qualifying date in the 244 Assembly Constituencies of Karnataka, the revision has been completed in 221 Assembly Constituencies of Karnataka state (except 162-Shivajinagar, 169-Chickpet, 174-Mahadevapura Assembly Constituencies) as per the directions of the Election Commission of India. Final Electoral Rolls-2023 of 221 Assembly Constituencies have been published in the offices of District Election Officers of all the districts, Electoral Registration Officers, Assistant Electoral Registration Officers and all polling stations coming under the jurisdiction for the information of public on 05.01.2022, i.e., Today. For the remaining Assembly Constituencies of 162-Shivajinagar, 169-Chickpet, 174-Mahadevapura, Final Electoral Rolls will be published on 15.01.2023. The general public are requested to check as to whether their names have been included in the list with correct information.
- 2. During the period of Continuous Updation period, applications can be submitted in online mode using the portals NVSP, Voter Portal or the Voter Helpline Mobile app.

At State level, wide publicity has been given by the Chief Electoral Officer, Karnataka about the Special Summary Revision of the Electoral Rolls through press notes to create awareness among the general public. The District Election Officers at the district level and the Electoral Registration Officer at subdivision level and Assistant Electoral Registration Officer at Taluk level have also given publicity regarding Special Summary Revision through various media. Further, the Chief Electoral Officer, District Election Officers and Electoral Registration Officers have conducted meetings with the Political Parties at State, District and Assembly Constituency levels respectively and shared the copies of the Draft Electoral Rolls-2023 published on 09.11.2022.

During the revision activities in the 221 Assembly Constituencies, the names of voters detected under Photo Similar Entries, Demographically Similar Entries, Dead, Shifted, Absentee etc have been deleted for purification of electoral rolls. After the said deletions, the number of voters as per the Final Electoral Rolls-2023 is 5,05,48,553. Among them, the number of General Voters is 5,05,00,739 and the number of service voters is 47,814. Among the General Voters, 2,54,03,511 are male and 2,50,92,726 are female and 4,502 are others.

b) Among the 221 Assembly Constituencies, Bangalore South Assembly Constituency of Bangalore Urban district is having highest number of voters i.e., 6,50,53 and Shrigeri Assembly Constituency of Chikkamagaluru distruct is having least number of voters i.e., 1,66,521.

- e) As per the said Final Electoral Rolls-2023, the ratio of Electors:Population is 68.27%
- f) The Photo coverage: As per the Final Electoral Rolls-2022 it was 100%. As per the Final Electoral Rolls-2023, the photo coverage is also 100%.

Inclusion, correction of entries and deletion of the names of the voters:

Form 8 is required to be submitted for correction of entries in the electoral rolls.

Previously, during the annual revisions of Electoral Rolls, persons who have completed 18 years of age were only allowed to register themselves as voters. At present the youngsters, who have crossed the age of 17 can submit applications in advance to get enrolled. There are four qualifying dates in a year for enrolment. viz., 1st January, 1st April, 1st July and 1st October. The youngsters who have completed 17 years of age may submit an application for inclusion of their names in the electoral rolls. Total number of advance applications for 1st April 2023 qualifying date from 17+ age group received is 25,299. When the age of the applicant crosses 18 years of age as on any one of the qualifying dates, necessary action will be initiated to process such application as per rules.
