- a) As per the Census of 2011, the Gender Ratio of the Bengaluru Urban District is 916. However, as per the Final Electoral Rolls-2023, the Gender Ratio is 854.
- b) As per the said Final Electoral Rolls-2023, the ratio of Electors: Population of Bengaluru Urban District is 58.52%
- c) The Photo coverage: As per the Final Electoral Rolls-2022 it was 100%. As per the Final Electoral Rolls-2023, the photo coverage is also 100%.

#### Inclusion, correction of entries and deletion of the names of the voters:

Form 8 is required to be submitted for correction of entries in the electoral rolls. Previously, during the annual revisions of Electoral Rolls, persons who have completed 18 years of age were only allowed to register themselves as voters. At present the youngsters, who have crossed the age of 17 can submit applications in advance to get enrolled. There are four qualifying dates in a year for enrolment. viz., 1<sup>st</sup> January, 1<sup>st</sup> April, 1<sup>st</sup> July and 1<sup>st</sup> October. The youngsters who have completed 17 years of age may submit an application for inclusion of their names in the electoral rolls. Total number of advance applications for 1<sup>st</sup> April 2023 qualifying date from 17+ age group received is 87. When the age of the applicant crosses 18 years of age as on any one of the qualifying dates, necessary action will be initiated to process such application as per rules.
