b. Cases booked:

- > Flying Squads, SSTs and Police authorities have booked **1795** FIR's with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- > **69656** arms have been got deposited, **18** arms were impounded, **20** arms license have been cancelled, **4529** cases are booked under preventive sections of CrPC, out of which **7238** persons were bounded over. **12107** Non-bailable warrants were executed from the date of announcement of elections.
- Excise Department has booked **2288** Heinous Cases, **1892** cases for Breach of Licence Conditions, **75** NDPS and **14045** cases under Section 15 (a) of Karnataka Excise act 1965. And also **1556** different types of Vehicles have been seized.

c. Special Report:

- > FST team has seized **23,880** Ltrs of Liquor worth Rs. **25,00,000** in Nippani Constituency of Belagavi District.
- > FST Team has seized Freebies worth Rs. **58,59,400** in Shivajinagar Constituency of Bangalore City Central District.
- > FST Team has seized Cash of Rs.**25,00,000** in chickpete Constituency of Bangalore City south District.

2. Public Grievance Redressal:

Out of the **11,143** calls received through Voter Helplines, **10,940** people have sought information, **26** have given feedback, **25** have made suggestions and **152** have registered complaints. All **11,143** calls have been disposed off. In addition, **6,542** complaints have been registered by the citizens on NGRS portal, out of which, **6,229** complaints have been disposed off.

3. cVIGIL:

4,687 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission (2612), Money Distribution (66), Posters without mandatory declaration(162), Display of Firearms, Intimidation (57), Distribution of gifts/coupons (64), Distribution of Liquor (44), property defacement (251), vehicle or convoy without permission (90), out of which 3,939 Complaints are found to be correct and action has been taken.

4. Media:

The complaints have been received through emails (261) and letters (333), Newspapers (90), TV Channels (44), Social media (66). Out of the total 794 Complaints 551 have been disposed off.

5. SUVIDHA:

Under SUVIDHA **8,821** Applications for permissions have been received; out of which **6,824** have been accepted and **1,398** have been rejected. **72** are in progress, **316** are pending and **211** are cancelled.
