a. Cases booked:

- Flying Squads, SSTs and Police authorities have booked 2,226 FIR's with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- 69,805 arms have been got deposited, 18 arms were impounded, 20 arms license have been cancelled, 5,329 cases are booked under preventive sections of CrPC, out of which 9,569 persons were bounded over. 14,885 Non-bailable warrants were executed from the date of announcement of elections.
- Excise Department has booked 2,853 Heinous Cases, 2,549 cases for Breach of Licence Conditions, 89 NDPS and 28,127 cases under Section 15 (a) of Karnataka Excise act 1965. And also 1,962 different types of Vehicles have been seized.

b. Special Report:

- FST team has seized 50.461 Kg of Drugs worth Rs. 25,74,000 Pulakeshinagara Constituency of Bangalore City East District.
- SST team has seized Cash of Rs.93,50,000 in Kumta Constituency of Uttara Kannada District
- SST team has seized Cash of Rs.50,00,000 in Gokak Constituency of Belagavi District

2. Public Grievance Redressal:

Out of the **19,908** calls received through Voter Helplines, **19,152** people have sought information, **34** have given feedback, **35** have made suggestions and **687** have registered complaints. All **19,908** calls have been disposed off. In addition, **8,490** complaints have been registered by the citizens on NGRS portal, out of which, **8,208** complaints have been disposed off.

3. cVIGIL:

8,880 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission (4,733), Money Distribution (106), Posters without mandatory declaration (228), Display of Firearms, Intimidation (82), Distribution of gifts/coupons (96), Distribution of Liquor (78), property defacement (345), vehicle or convoy without permission (151), out of which 7,569 Complaints are found to be correct and action has been taken.

4. Media:

The complaints have been received through emails (335) and letters (500), Newspapers (142), TV Channels (56), Social media (79). Out of the total 1,112 Complaints 841 have been disposed off.

5. SUVIDHA:

Under SUVIDHA **15,309** Applications for permissions have been received; out of which **12,364** have been accepted and **1,737** have been rejected. **243** are in progress, **643** are pending and **322** are cancelled.
