#### a. Cases booked:

- ➤ Flying Squads, SSTs and Police authorities have booked **2,896** FIR's with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- ➤ **69,865** arms have been got deposited, **18** arms were impounded, **20** arms license have been cancelled, **5,779** cases are booked under preventive sections of CrPC, out of which **11,819** persons were bounded over. **17,251** Non-bailable warrants were executed from the date of announcement of elections.
- Excise Department has booked **3,595** Heinous Cases, **3,366** cases for Breach of Licence Conditions, **102** NDPS and **35,876** cases under Section 15 (a) of Karnataka Excise act 1965. And also **2,501** different types of Vehicles have been seized.

## b. Special Report:

- ➤ Income Tax Department has seized Cash Rs.1,10,00,000 & 1.855 KG Gold worth Rs.97,56,625 in Basavangudi Constituency of Bangalore Urban District.
- > FST team has seized Cash of **Rs.2,00,00,000** in Maddur Constituency of Mandya District
- > FST team has seized Cash of **Rs.50,00,000** in Srirangapatna Constituency of Mandya District
- > FST team has seized Freebies worth **Rs.25,10,000** in Bailhongal Constituency of Belagavi District.

## 2. Public Grievance Redressal:

Out of the **35874** calls received through Voter Helplines, **32862** people have sought information, **65** have given feedback, **56** have made suggestions and **2891** have registered complaints. All **35874** calls have been disposed off. In addition, **12022** complaints have been registered by the citizens on NGRS portal, out of which, **11693** complaints have been disposed off.

# 3. cVIGIL:

17,738 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission (10,436), Money Distribution (206), Posters without mandatory declaration (261), Display of Firearms, Intimidation (104), Distribution of gifts/coupons (255), Distribution of Liquor (154), property defacement (439), vehicle or convoy without permission (318), out of which 16,000 Complaints are found to be correct and action has been taken.

#### 4. Media:

The complaints have been received through emails (492) and letters (835), Newspapers (164), TV Channels (72), Social Media (112). Out of the total 1,690 Complaints 1,376 have been disposed off.

#### 5. SUVIDHA:

Under SUVIDHA **26,990** Applications for permissions have been received; out of which **23,977** have been accepted and **2,271** have been rejected. **55** are in progress, **204** are pending and **483** are cancelled.
