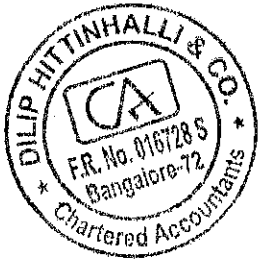
**TO THE MEMBERS OF NAVABHARATH SENA**

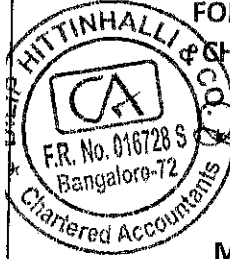

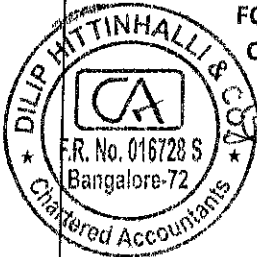
