2. Cases booked:

- a. Flying Squads, SSTs and Police authorities have booked **496** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b. **72,627** arms have been got deposited, **836** arms were impounded, **8** arms licenses have been cancelled, **4,175** cases are booked under preventive sections of CrPC, out of which **4,862** persons were bounded over.
- c. Excise Department has booked 552 Heinous Cases, 430 cases for Breach of Licence Conditions, 29 NDPS and 1,815 cases under Section 15 (a) of Karnataka Excise act 1965 and also 329 different types of Vehicles have been seized.

3. Special Report:

- a. Police Department has seized cash of **Rs. 5,36,00,000 in Magadi** AC Hejjala checkpost in Bangalore Rural Parliamentary Constituency.
- b. PSI investigation Town PS Hospet (Vijayanagara) has seized 203 kg of Sandalwood worth of Rs. 30,45,000 in Bellary Parliamentary Constituency.
- c. SST Hunasur team has seized cash of **Rs. 15,96,078** in Mysore Parliamentary Constituency.
- d. Ballary city police station Team has seized cash of **Rs. 26,00,000** in Ballary Parlimenatry Constituency, Ballari dist.

4. Public Grievance Redressal:

Out of the **4,131** calls received through Voter Helpline, **4,124** people have sought information, **1** have given feedback, **0** have made suggestions and **7** have registered complaints. Cumulatively **4,131** calls have been disposed off. In addition, **3,212** complaints have been registered by the citizens on NGRS portal, out of which, **2,746** complaints have been disposed off.

5. cVIGIL:

2,902 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **1754**, Posters without mandatory declaration **211**, property defacement **35**, Money Distribution **19**, Distribution of gifts/coupons **12**, Campaigning during ban period **07**, Distribution of Liquor **09**, Vehicle or convoy without permission **10**, Religious or communal speeches/messages **05**, Display of Firearms, Intimidation **04** out of which **2559** Complaints are found to be correct and action has been taken.

6. Media:

The complaints have been received through emails **42**, and letters **103**, Newspapers **03**, TV Channels **05** and Social Media **15** Out of the total **168** Complaints, **168** have been disposed off.

7. ENCORE:

Under ENCORE, **424** Applications for permissions have been received; out of which **242** have been accepted and **96** have been rejected. **05** are in progress, **70** are pending and **11** are cancelled.
