## 3. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **909** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) 94,417 arms have been got deposited, 882 arms were impounded, 15 arms licenses have been cancelled, 7,819 cases are booked under preventive sections of CrPC, out of which 8,406 persons were bounded over.
- c) Excise Department has booked 922 Heinous Cases, 797 cases for Breach of Licence Conditions, 49 NDPS and 3,342 cases under Section 15 (a) of Karnataka Excise act 1965 and also 535 different types of Vehicles have been seized.

#### 4. Special Reports:

- a) Bangalore city Market Police Station Team has seized Cash **Rs. 10,00,000** in Gandhinagar, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.
- b) Bangalore City Varthur Police Station Team has seized 5.180 Kg of Ganja value Rs. 10,50,000 in Gunjur, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.
- c) Karnataka Railway Wadi Police Team has seized **22 Kg** of Ganja value **Rs. 22,00,000** in Raichur Railway Circle, Raichur Parliamentary Constituency, Raichur Dist.
- d) FST Team has seized **5.29643 Kg** of Gold Ornaments value **Rs. 3,55,00,000** in Hiriyur, Chitradurga Parliamentary Constituency, Chitradurga Dist.

#### 5. Public Grievance Redressal:

Out of the **7,244** calls received through Voter Helpline, **7,228** people have sought information, **1** have given feedback, **0** have made suggestions and **15** have registered complaints. Cumulatively **7,244** calls have been disposed off. In addition, **5,377** complaints have been registered by the citizens on NGRS portal, out of which, **4,936** complaints have been disposed off.

#### 6. cVIGIL:

**7,372** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **4,476**, Posters without mandatory declaration **398**, property defacement **108**, Money Distribution **80**, Distribution of gifts/coupons **27**, Campaigning during ban period **23**, Distribution of Liquor **25**, Vehicle or convoy without permission **20**, Religious or communal speeches/messages **18**, Display of Firearms, Intimidation **12**. Out of which **6,606** Complaints are found to be correct and action has been taken.

#### 7. Media:

The complaints have been received through emails **72**, and letters **219**, Newspapers **10**, TV Channels **12** and social media **23** Out of the total **336** Complaints, **336** have been disposed off.

#### 8. ENCORE:

Under ENCORE, **985** Applications for permissions have been received; out of which **702** have been accepted and **184** have been rejected. **06** are in progress, **46** are pending and **47** are cancelled.
