#### 2. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **969** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) Excise Department has booked **974** Heinous Cases, **884** cases for Breach of Licence Conditions, **50** NDPS and **3,682** cases under Section 15 (a) of Karnataka Excise act 1965 and also **567** different types of Vehicles have been seized.

## 3. Special Reports:

- a) Bangalore City SJ Park Police Station Team has seized 17.425 Kg of Ganja value Rs. 10,20,000 in SJ Park, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.
- b) SST Team has seized 128.74 gm of Gold Ornaments with Coral value Rs. 6,00,000 and Cash Rs 14,63,530 total Rs. 20,63,530 in Batawadi Check post, Tumkur Parliamentary Constituency, Tumkur Dist.
- c) Excise department has seized 7,344 ltrs of IML worth Rs. 29,50,486 in K.S.B.C.L Depo, APMC Yard, Sirsi, Uttara Kannada District. Offence Mismatch found in Excise Adhesive Labels affixed on the carton boxes and liquor which were being supplied from 'Inbrew Beverages Pvt Ltd, Hassan District. Uttara Kannada Parliamentary Constituency, Uttara Kannada District. (BLC Case FIR No: 18/2023-24/3204IE/320411, Dated: 28/03/2024).
- d) Excise department has seized 8,970 ltrs of Beer worth Rs.29,92,910 in KSBCL Depo 2, Whitefield, Bengaluru 560066. Offence 2D/3D Barcode Stickers which were affixed on the carton boxes of liquor were not scanned, which were being supplied from 'Carlsberg India Pvt Ltd, Immavu Village, Nanjangudu Taluk, Mysore District. Bangalore Central Parliamentary Constituency, Bangalore Urban District (BUD-5), Bengaluru. (FIR No: 15/2023-24/4003DySE/400309, Dated: 28/03/2024).

### 4. Public Grievance Redressal:

Out of the **7,899** calls received through Voter Helpline, **7,864** people have sought information, **3** have given feedback, **2** have made suggestions and **30** have registered complaints. Cumulatively **7,899** calls have been disposed off. In addition, **5,677** complaints have been registered by the citizens on NGRS portal, out of which, **5,358** complaints have been disposed off.

## 5. cVIGIL:

**8,703** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **5,321**, Posters without mandatory declaration **458**, property defacement **134**, Money Distribution **105**, Distribution of gifts/coupons **29**, Campaigning during ban period **23**, Distribution of Liquor **26**, Vehicle or convoy without permission **25**, Religious or communal speeches/messages **18**, Display of Firearms, Intimidation **12**. Out of which **7,918** Complaints are found to be correct and action has been taken.

#### 6. Media:

The complaints have been received through emails **74**, and letters **253**, Newspapers **11**, TV Channels **13** and Social Media **24** Out of the total **375** Complaints, **375** have been disposed off.

#### 7. ENCORE:

Under ENCORE, **1,114** Applications for permissions have been received; out of which **807** have been accepted and **198** have been rejected. **07** are in progress, **54** are pending and **48** are cancelled.
