**3. Cases Booked:**

- Flying Squads, SSTs and Police authorities have booked **1,205** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- Excise Department has booked **1,248** Heinous Cases, **1,203** cases for Breach of Licence Conditions, **79** NDPS and **5,327** cases under Section 15 (a) of Karnataka Excise act 1965 and also **732** different types of Vehicles have been seized.

**4. Special Reports:**

**Excise department seizures:**

- 7,383.60** ltrs of liquor (IML) worth of **Rs.46,49,939** lakhs and Vehicle Lorry worth of **Rs.10,00,000** near KSBCL Depo, Kengeri, Boddabele Village, Muniyappa Industrial Layout, Channappa Road, Sy No.115/7D, Bangalore.
- 8,970** ltrs of liquor (Beer) worth of **Rs.25,37,753** lakhs in KSBCL Depo-1, Neerumarga-Bondathela Village, Mangalore Taluk, Dakshina Kannada District.

- c. **10,020 ltrs** of liquor (Beer) worth of **Rs.36,06,000** lakhs and Vehicle Lorry worth of **Rs.15,00,000** in KSWC Godown, APMC Yard Premises, Kolar Main Road, Bangarpet Taluk, Kolar District.

**5. Public Grievance Redressal:**

Out of the **11,373** calls received through Voter Helpline, **11,291** people have sought information, **8** have given feedback, **10** have made suggestions and **64** have registered complaints. Cumulatively **11,373** calls have been disposed off. In addition, **7,242** complaints have been registered by the citizens on NGRS portal, out of which, **7,076** complaints have been disposed off.

**6. cVIGIL:**

**14,419** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **8,973**, Posters without mandatory declaration **700**, property defacement **200**, Money Distribution **110**, Distribution of gifts/coupons **42**, Campaigning during ban period **32**, Distribution of Liquor **53**, Vehicle or convoy without permission **32**, Religious or communal speeches/messages **25**, Display of Firearms, Intimidation **16**. Out of which **13,521** Complaints are found to be correct and action has been taken.

**7. Media:**

The complaints have been received through emails **112**, and letters **345**, Newspapers **16**, TV Channels **19** and Social Media **32** Out of the total **524** Complaints, **524** have been disposed off.

**8. ENCORE:**

Under ENCORE, **1945** Applications for permissions have been received; out of which **1463** have been accepted and **302** have been rejected. **26** are in progress, **76** are pending and **78** are cancelled.
