# 1. Validly Nominated Candidates of Phase 2 PCs of Karnataka:

The scrutiny of nominations was undertaken on 05.04.2024 in 13PCs out of 14 PCs of Phase 2 election. The scrutiny proceedings of Bangalore South were adjourned today and the scrutiny of nominations completed today. #### 3. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **1,337** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) Excise Department has booked **1,528** Heinous Cases, **1,654** cases for Breach of Licence Conditions, **102** NDPS and **7,360** cases under Section 15 (a) of Karnataka Excise act 1965 and also **916** different types of Vehicles have been seized.

# 4. Special Reports:

Bangalore City Police, Central Crime Branch Team has seized 5.5 Kg Ganja value **Rs. 10,00,000** in gunjurpalya, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist

#### 5. Public Grievance Redressal:

Out of the **13731** calls received through Voter Helpline, **13,606** people have sought information, **14** have given feedback, **14** have made suggestions and **97** have registered complaints. Cumulatively **13731** calls have been disposed off. In addition, **8461** complaints have been registered by the citizens on NGRS portal, out of which, **8166** complaints have been disposed off.

## 6. cVIGIL:

17748 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission 10965, Posters without mandatory declaration 837, property defacement 256, Money Distribution 127, Distribution of gifts/coupons 55, Campaigning during ban period 35, Distribution of Liquor 72, Vehicle or convoy without permission 34, Religious or communal speeches/messages 27, Display of Firearms, Intimidation 18. Out of which 16782 Complaints are found to be correct and action has been taken.

## 7. Media:

The complaints have been received through emails **132**, and letters **428**, Newspapers **18**, TV Channels **24** and Social Media **37** Out of the total **639** Complaints, **639** have been disposed off.

## 8. ENCORE:

Under ENCORE, **2,545** Applications for permissions have been received; out of which **1,937** have been accepted and **377** have been rejected. **10** are in progress, **135** are pending and **86** are cancelled.
