### 3. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **1,422** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) Excise Department has booked **1,726** Heinous Cases, **1,989** cases for Breach of Licence Conditions, **109** NDPS and **9,183** cases under Section 15 (a) of Karnataka Excise act 1965 and also **1,048** different types of Vehicles have been seized.

### 4. Special Reports:

- a) Ballary City Brucepet Police Station Team has seized Cash **Rs. 5,60,000** & 3 Kg Gold, 68 Kg Silver, 103Kg Old Silver Total value **Rs. 7,06,00,000** in Brucepet, Ballary Parliamentary Constituency, Ballary Dist.
- b) FST Team has Seized 1411 Fans items Value **Rs. 10,00,000** in Devanahalli, Chikkaballapura Parliamentary Constituency, Bangalore Urban Dist.
- c) Income tax department has seized cash of **Rs. 2,62,00,000** in Bangalore Central Parliamentary Constituency.

### 5. Public Grievance Redressal:

Out of the **15,127** calls received through Voter Helpline, **14,992** people have sought information, **16** have given feedback, **16** have made suggestions and **103** have registered complaints. Cumulatively **15,127** calls have been disposed off. In addition, **9,127** complaints have been registered by the citizens on NGRS portal, out of which, **8,924** complaints have been disposed off.

### 6. cVIGIL:

**19,201** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **11,802**, Posters without mandatory declaration **911**, property defacement **270**, Money Distribution **132**, Distribution of gifts/coupons **61**, Campaigning during ban period **35**, Distribution of Liquor **83**, Vehicle or convoy without permission **36**, Religious or communal speeches/messages **30**, Display of Firearms, Intimidation **18**. Out of which **18,213** Complaints are found to be correct and action has been taken.

### 7. Media:

The complaints have been received through emails **147**, and letters **470**, Newspapers **20**, TV Channels **27** and Social Media **42** Out of the total **706** Complaints, **706** have been disposed off.

### 8. ENCORE:

Under ENCORE, **2,866** Applications for permissions have been received; out of which **2,276** have been accepted and **417** have been rejected. **07** are in progress, **71** are pending and **95** are cancelled.
