#### 4. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **1,505** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) Excise Department has booked 1,848 Heinous Cases, 2,217 cases for Breach of Licence Conditions, 112 NDPS and 10,718 cases under Section 15 (a) of Karnataka Excise act 1965 and also 1,118 different types of Vehicles have been seized.

#### 5. Special Reports:

Bangalore City, Commercial Street Police Station Team has seized **0.020 Kg Drugs** (MDMA) of value **Rs. 1,00,000** & 45 Kg Drugs (Ganja) value **Rs. 11,25,000 and** Cash **1,400** total value **Rs. 12,26,400** in Shivajinagar, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.

#### 6. Public Grievance Redressal:

Out of the **16,309** calls received through Voter Helpline, **16,157** people have sought information, **17** have given feedback, **17** have made suggestions and **118** have registered complaints. Cumulatively **16,309** calls have been disposed off. In addition, **15,334** complaints have been registered by the citizens on NGRS portal, out of which, **15,112** complaints have been disposed off.

### 7. cVIGIL:

**20,360** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **12,422**, Posters without mandatory declaration **938**, property defacement **282**, Money Distribution **142**, Distribution of gifts/coupons **72**, Campaigning during ban period **37**, Distribution of Liquor **97**, Vehicle or convoy without permission **56**, Religious or communal speeches/messages **32**, Display of Firearms, Intimidation **21**. Out of which **19,265** Complaints are found to be correct and action has been taken.

#### 8. Media:

The complaints have been received through emails **149**, and letters **488**, Newspapers **24**, TV Channels **30** and Social Media **44** Out of the total **735** Complaints, **735** have been disposed off.

#### 9. ENCORE:

Under ENCORE, **3,312** Applications for permissions have been received; out of which **2,514** have been accepted and **458** have been rejected. **14** are in progress, **207** are pending and **119** are cancelled.
