2. Cases Booked:

- Flying Squads, SSTs and Police authorities have booked **1,650** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- Excise Department has booked **2,086** Heinous Cases, **2,707** cases for Breach of Licence Conditions, **123** NDPS and **13,833** cases under Section 15 (a) of Karnataka Excise act 1965 and also **1,263** different types of Vehicles have been seized.

3. Special Reports:

- FST Team has seized **22.96 Kg** Silver bars value **Rs.10,06,985** in Gandhinagar, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.
- Karnataka Railway Police Team has seized **14.840 Kg** Ganja value **Rs 14,84,000** in Byappanahalli, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.
- FST Team has seized Cash **Rs. 19,00,000** in Munirabad, Koppal Parliamentary Constituency, Koppal Dist.

4. Public Grievance Redressal:

Out of the **17,719** calls received through Voter Helpline, **17,548** people have sought information, **20** have given feedback, **19** have made suggestions and **132** have registered complaints. Cumulatively **17,719** calls have been disposed off. In addition, **11,016** complaints have been registered by the citizens on NGRS portal, out of which, **10,867** complaints have been disposed off.

5. cVIGIL:

22,192 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **13,361**, Posters without mandatory declaration **1,029**, property defacement **307**, Money Distribution **187**, Distribution of gifts/coupons **101**, Campaigning during ban period **44**, Distribution of Liquor **124**, Vehicle or convoy without permission **67**, Religious or communal speeches/messages **44**, Display of Firearms, Intimidation **23**. Out of which **20,929** Complaints are found to be correct and action has been taken.

6. Media:

The complaints have been received through emails **179**, and letters **533**, Newspapers **24**, TV Channels **31** and Social Media**48** Out of the total **815** Complaints, **815** have been disposed off.

7. ENCORE:

Under ENCORE, **4,527** Applications for permissions have been received; out of which **3,307** have been accepted and **654** have been rejected. **52**are in progress, **333** are pending and **181** are cancelled.
