**27,505 (74.97%)** voters in the age group of 85+ have casted their votes at their homes out of **36,689** voters approved for home voting. Similarly, **9,060 (76.01%)** PwD voters have casted their votes at their home out of **11,920** voters approved for home voting on 13.04.2024. In total **36,565 (75.22%)** voters have cast their votes out of **48,609** voters approved.

#### **7. Public Grievance Redressal:**

Out of the **19,994** calls received through Voter Helpline, **19,802** people have sought information, **25** have given feedback, **23** have made suggestions and **144** have registered complaints. Cumulatively **19,994** calls have been disposed off. In addition, **12,299** complaints have been registered by the citizens on NGRS portal, out of which, **12,047** complaints have been disposed off..

#### **8. cVIGIL:**

**23,842** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **14,171**, Posters without mandatory declaration **1,080**, property defacement **319**, Money Distribution **162**, Distribution of gifts/coupons **116**, Campaigning during ban period **49**, Distribution of Liquor **132**, Vehicle or convoy without permission **80**, Religious or communal speeches/messages **50**, Display of Firearms, Intimidation **23**. Out of which **22,510** Complaints are found to be correct and action has been taken.

#### **9. Media:**

The complaints have been received through emails **193**, and letters **585**, Newspapers **27**, TV Channels **33** and Social Media **56** Out of the total **894** Complaints, **894** have been disposed off.

#### **10. ENCORE:**

Under ENCORE, **5,769** Applications for permissions have been received; out of which **4,279** have been accepted and **896** have been rejected. **50** are in progress, **305** are pending and **239** are cancelled.
