# GENERAL ELECTIONS TO LOK SABHA 2024 and Bye election to 36-Shorapura Legislative Assembly Constituency 2024 PRESS NOTE

# 1. Absentee Voters employed in Essential Services (AVES):

The casting of votes by electors of AVES category was held **from 19.04.2024 to 21.04.2024** in specified Postal Voting Centres (PVC) of Phase 2 - 14 Parliamentary Constituencies going for poll on **26.04.2024**. Out of **59,035** AVES category of electors, **53,104 (89.95%)** electors have casted their votes in the Postal Voting Centres.

#### 4. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **2,016** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) Excise Department has booked 2,819 Heinous Cases, 4,232 cases for Breach of Licence Conditions, 166 NDPS and 24,505 cases under Section 15 (a) of Karnataka Excise act 1965 and also 1,765 different types of Vehicles have been seized.

# 5. Special Report:

- a) SST Team has seized Cash **Rs. 2,00,00,000** in APMC Market Binni Mill Tank Bund Road Checkpost, Chamrajpete, Bangalore Central Parliamentary Constituency, Bangalore Urban Dist.
- b) FST Team has seized Cash **Rs. 50,00,000** in Basavana Bagewadi, Bijapur Parliamentary Constituency. Vijayapur Dist.
- c) Income Tax department has seized Cash **Rs. 28,00,000** in 2<sup>nd</sup> Stage Nagarabhavi, Bangalore South Parliamentary Constituency, Bengaluru Urban district.
- d) Income Tax department has seized Cash **Rs. 45,00,000** in Agrahara, Chamrajpet, Bangalore Central Parliamentary Constituency, Bengaluru Urban district.

#### 6. Public Grievance Redressal:

Out of the **26,178** calls received through Voter Helpline, **25,936** people have sought information, **32** have given feedback, **28** have made suggestions and **182** have registered complaints. Cumulatively **26,178** calls have been disposed off. In addition, **15,858** complaints have been registered by the citizens on NGRS portal, out of which, **15,460** complaints have been disposed off.

#### 7. cVIGIL:

**26,816** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **15,870**, Posters without mandatory declaration **1119**, property defacement **326**, Money Distribution **188**, Distribution of gifts/coupons **128**, Campaigning during ban period **53**, Distribution of Liquor **148**, Vehicle or convoy without permission **92**, Religious or communal speeches/messages **62**, Display of Firearms, Intimidation **52**. Out of which **25,314** Complaints are found to be correct and action has been taken.

#### 8. Media:

The complaints have been received through emails **248**, and letters **711**, Newspapers **32**, TV Channels **42** and Social Media **64** Out of the total **1,097** Complaints, **1,097** have been disposed off.

#### 9. ENCORE:

Under ENCORE, **8,187** Applications for permissions have been received; out of which **6,413** have been accepted and **1,173** have been rejected. **41** are in progress, **244** are pending and **316** are cancelled.
