4. Public Grievance Redressal:

Out of the **27,735** calls received through Voter Helpline, **27,472** people have sought information, **35** have given feedback, **32** have made suggestions and **196** have registered complaints. Cumulatively **27,735** calls have been disposed off. In addition, **16,618** complaints have been registered by the citizens on NGRS portal, out of which, **16,139** complaints have been disposed off.

5. cVIGIL:

27,284 Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **16,101**, Posters without mandatory declaration **1,125**, property defacement **332**, Money Distribution **189**, Distribution of gifts/coupons **129**, Campaigning during ban period **54**, Distribution of Liquor **150**, Vehicle or convoy without permission **101**, Religious or communal speeches/messages **63**, Display of Firearms, Intimidation **54**. Out of which **25,750** Complaints are found to be correct and action has been taken.

6. Media:

The complaints have been received through emails **255**, and letters **731**, Newspapers **32**, TV Channels **44** and Social Media **67** Out of the total **1,129** Complaints, **1,129** have been disposed off.

7. ENCORE:

Under ENCORE, **8,511** Applications for permissions have been received; out of which **6,773** have been accepted and **1,197** have been rejected. **26** are in progress, **187** are pending and **328** are cancelled.
