# GENERAL ELECTIONS TO LOK SABHA 2024 and Bye election to 36-Shorapura Legislative Assembly Constituency 2024 PRESS NOTE

1. Repoll in Polling Station No. 146, Government Lower Primary School, Indiganatha, 221- Hanur Assembly Constituency of 21- Chamarajanagara Parliamentary Constituency:

Based on the reports submitted by the Returning Officer and General Observer for the 22-Chamarajanagar Parliamentary Constituency and after considering all relevant circumstances, the Election Commission of India has declared, in accordance with Sections 58(2) and 58A(2) of the Representation of the People Act, 1951, that the poll conducted on 26.04.2024 at Polling Station No. 146, Govt. Lower Primary School, Indiganatha, 221-Hanur Assembly Constituency of the 21-Chamarajanagar Parliamentary Constituency, falling under Chamarajanagar District, to be void and appoints the 29<sup>th</sup> April, 2024 (Monday), as the date and fixes the hours from 07:00AM to 06:00PM for taking a fresh poll at the said polling station in accordance with the Commissions instructions outlined in Chapter 13 of the Handbook for Returning Officers, 2023.

#### 2. Election Expenditure Monitoring: Seizures:

# 3. Cases Booked:

- a) Flying Squads, SSTs and Police authorities have booked **2,197** FIRs with regard to seizures of cash, liquor, drugs, precious metal and Freebies.
- b) Excise Department has booked 3,153 Heinous Cases, 4,927 cases for Breach of Licence Conditions, 180 NDPS and 29,036 cases under Section 15 (a) of Karnataka Excise act 1965 and also 1,945 different types of Vehicles have been seized.

### 4. Public Grievance Redressal:

Out of the **35,340** calls received through Voter Helpline, **35,029** people have sought information, **39** have given feedback, **35** have made suggestions and **237** have registered complaints. Cumulatively **35,340** calls have been disposed off. In addition, **19,860** complaints have been registered by the citizens on NGRS portal, out of which, **18,248** complaints have been disposed off.

#### 5. cVIGIL:

**28,819** Complaints have been received through cVIGIL application. Major complaints received are related to Posters/Banners without permission **16,799**, Posters without mandatory declaration **1,129**, property defacement **342**, Money Distribution **254**, Distribution of gifts/coupons **144**, Campaigning during ban period **70**, Distribution of Liquor **156**, Vehicle or convoy without permission **135**, Religious or communal speeches/messages **85**, Display of Firearms, Intimidation **64** out of which **27,172** Complaints are found to be correct and action has been taken.

#### 6. Media:

The complaints have been received through emails **329**, and letters **832**, Newspapers **35**, TV Channels **77** and Social Media **75** Out of the total **1,348** Complaints, **1,348** have been disposed off.

# 7. ENCORE:

Under ENCORE, **9,916** Applications for permissions have been received; out of which **8,061** have been accepted and **1,298** have been rejected. **20** are in progress, **183** are pending and **354** are cancelled.
